911 OPERATING SURCHARGE  
REAUTHORIZATION PROPOSAL

For the period beginning on January 1, 2017 and continuing through the month of December in the year 2021, shall Alpena County be authorized to continue to assess a monthly surcharge of up to and not to exceed \$3.00 in the monthly billings of landline, wireless and VOIP service suppliers within the geographic boundaries of Alpena County; to be used exclusively for the continuing funding of 911 emergency telephone call answering and dispatch services within Alpena County, including facilities, equipment and operations?

**ALPENA TOWNSHIP PROPOSALS**

PRESQUE ISLE ELECTRIC & GAS CO-OP FRANCHISE

The Township of Alpena on November 2, 2015 granted to Presque Isle Electric & Gas Co-Op a franchise for the purpose of construction, maintaining, and commercially using electric lines on, under, along, and across the highways, streets, alleys, bridges, and other public places, and to conduct a local electric business in the Township of Alpena, County of Alpena, Michigan, for a period of thirty (30) years from August 1, 2018 to August 1, 2048.

Shall the grant of franchise to Presque Isle Electric & Gas Co-Op be made irrevocable for said thirty (30) year term?

**LONG RAPIDS TOWNSHIP PROPOSALS**

ONE MILL FOR TEN YEARS TO PROVIDE EMERGENCY RESPONSE AND FIRE PROTECTION SERVICES

Shall the Township of Long Rapids, County of Alpena, Michigan, impose a tax of one mill for a period of 10 years for the purpose of differing the cost of maintaining and equipping the Long Rapids Township Fire Department and Emergency Response First Responder services? The estimated revenue of one mill (\$1.00 per \$1000.00 of taxable value) to be levied in 2017 is \$36,384.83.

**WILSON TOWNSHIP PROPOSALS**

1 mill for the Purchase of Emergency Fire Vehicle

Shall the tax limitation on general ad valorem taxes within Wilson Township imposed under Article IX, section 6 of the Michigan Constitution be increased for said Township by 1.000 mill (\$1.00 per \$1000.00 of taxable value) for a period of 5 years, from 2017 through 2022, inclusive with the funds raised to be used for the purchase of an emergency fire vehicle and appropriate equipment for such vehicle, and shall Wilson Township levy such increase in millage for such purposes during such period, which increase will raise in the first year an estimated sum of \$64,000.00

## ALPENA-MONTMORENCY-ALCONA ESD PROPOSALS

### SPECIAL EDUCATION MILLAGE RENEWAL

This proposal will allow the intermediate school district to continue to levy special education millage previously approved by the electors.

Shall the limitation on the amount of taxes which may be assessed against all property in Alpena-Montmorency-Alcona Educational Service District, Michigan, be renewed for 1.3318 mills (\$1.3318 on each \$1,000 of taxable valuation) for a period of 10 years, 2017 to 2026, inclusive, to provide funds for the education of students with a disability; the estimate of the revenue the intermediate school district will collect if the millage is approved and levied in 2017 is approximately \$2,474,661 from local property taxes authorized herein (this is a renewal of millage that expires with the 2016 tax levy)?
