

Bail Bonds

Pursuant to MCL 750.167b(4), the circuit court annually creates an alphabetical list of bail bond agencies authorized to post bonds in the counties of Alpena and Montmorency. The annual bail bond list is published in January of each year. The most recent approved bail bondsmen list is available below.



The above is a list of sureties authorized by the Circuit Court to post criminal bonds in the counties of Alpena and Montmorency. Surety bonds presented by these bonding agents will be accepted and need not indicate written approval of said bonds by the Circuit Court.

This list is in accordance with the requirements of MCL 750.167b(4), requiring the Circuit Judge to complete a list of all persons engaged in the business of becoming surety upon bonds for compensation in criminal cases. This list shall be conspicuously posted in each place in which persons in custody of the law are detained, and one or more copies shall be kept in hand. When any person who is detained requests any person in charge thereof to furnish the name of a bondsman, or to put him in communication with a bondsman, the list shall be furnished to the person so requesting, without recommendation, and the person in charge of the place of detention within a reasonable time shall put the person detained in communication with the bondsman.
