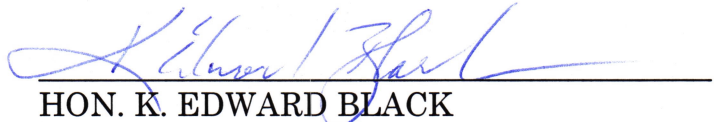

USE OF BAIL BONDS LIST

The foregoing constitutes the official list of sureties authorized by the 26th Judicial Circuit Court to post criminal bonds in Alpena and Montmorency Counties. Surety bonds submitted by the bonding agents appearing on this list shall be accepted and do not require separate written approval by the 26th Circuit Court.

This list is issued in compliance with MCL 750.167b(4), which requires the circuit judge to maintain a list of all persons engaged in the business of acting as surety for compensation in criminal cases. The list must be conspicuously posted in each location where persons are detained in custody of law enforcement, and one or more copies shall be maintained and readily available. Upon request by a detained person for the name of a bondsman or for assistance in contacting a bondsman, the list shall be provided without recommendation. The person in charge of the place of detention shall, within a reasonable time, place the detained person in communication with the bondsman selected.
